

HOLIDAY INN CLUB VACATIONS ONE IN A MILLION SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Holiday Inn Club Vacations One in a Million Sweepstakes ("Sweepstakes") is sponsored by Holiday Inn Club Vacations Incorporated ("Sponsor"), 9271 South John Young Parkway, Orlando, FL 32819 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

Non-winning entries will not carry forward into subsequent Entry Periods. The Administrator's computer is the Sweepstakes' official clock.

- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least twenty-five (25) years old at the time of entry. If there is more than one person attending the tour, the first name on the invitation to tour will be populated into the Official Entry Form and that person will be the entrant into the Sweepstakes. Upon submission of an official entry form, an eligible entrant will receive one (1) entry into the Sweepstakes.

ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN ORANGE COUNTY, FLORIDA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
